Before you invest in any fund, consider how the fund would work with your other investments and your tolerance for risk.

Effective on or about June 1, 2017, Series A shares outstanding as of May 31, 2017 will be re-designated to Series D shares of the fund.
 Effective June 1, 2017, the performance fee for this series of the fund will be based on a high water mark equal to the net asset value of the series as at that date.

WHAT DOES THE FUND INVEST IN?

The fund is a Canadian equity fund that seeks to generate strong long-term returns through the selection and management of investments that offer attractive risk-reward characteristics. In order to accomplish this objective the fund will focus primarily on small and mid-capitalization Canadian companies, however, up to 25% of the fund may be invested in foreign markets. The companies will typically have market capitalizations between \$100 million and \$5 billion.

The charts below give you a snapshot of the fund’s investments on March 31, 2017. The fund’s investments will change.

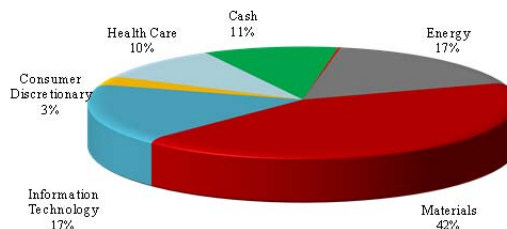

HOW RISKY IS IT?

The value of the fund can go down as well as up. You could lose money.

One way to gauge risk is to look at how much a fund’s returns change over time. This is called “volatility”.

In general, funds with higher volatility will have returns that change more over time. They typically have a greater chance of losing money and may have a greater chance of higher returns. Funds with lower volatility tend to have returns that change less over time. They typically have lower returns and may have a lower chance of losing money.

Risk Rating

AlphaNorth Asset Management has rated the volatility of this fund as **Medium to high**.

This rating is based on how much the fund’s returns have changed from year to year. It doesn’t tell you how volatile the fund will be in the future. The rating can change over time. A fund with a low risk rating can still lose money.

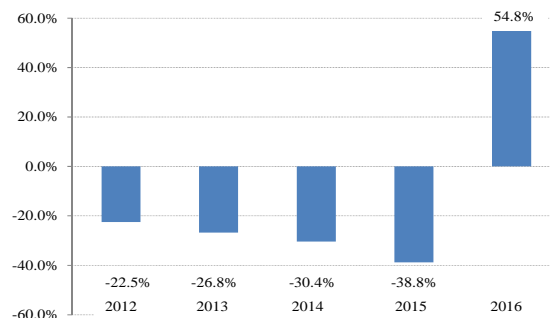
Like most mutual funds, this fund doesn’t have any guarantees. You may not get back the amount of money you invest.

HOW HAS THE FUND PERFORMED?

This section tells you how Series A shares of the fund have performed over the last 5 years. Returns are after expenses have been deducted. These expenses reduce the fund's returns.

Year-by-year returns

This chart shows how Series A shares of the fund have performed in each of the past 5 years. The fund dropped in value in 4 of the 5 years. The range of returns and change from year to year can help you assess how risky the fund has been in the past. It does not tell you how the fund will perform in the future.



Best and worst 3-month returns

This table shows the best and worst returns for Series A shares of the fund in a 3-month period over the past 5 years. The best and worst 3-month returns could be higher or lower in the future. Consider how much of a loss you can afford to take in a short period of time.

Average return

A person who invested \$1,000 in the fund on July 25, 2011 now has \$353. This works out to an annual return of (16.4%).

WHO IS THIS FUND FOR?

Investors Who:

- want capital appreciation over the long term
- are willing to accept medium to high volatility risk
- want exposure to Canadian small and mid-capitalization companies, and
- are willing to accept some fluctuation in value over the short to medium term.

! Do not buy this fund if you need a steady source of income from your investment.

A WORD ABOUT TAX

In general, you will have to pay income tax on any money you make on a fund. How much you pay depends on the tax laws where you live and whether or not you hold the fund in a registered plan, such as a Registered Retirement Savings Plan (RRSP) or a Tax-Free Savings Account (TFSA).

Keep in mind that if you hold your fund in a non-registered account, fund distributions are included in your taxable income, whether you get them in cash or have them reinvested.

HOW MUCH DOES IT COST?

The following tables show the fees and expenses you would pay to buy, own or sell Series A shares of the fund. The fees and expenses – including any commissions – can vary among series of a fund and among funds. Higher commissions can influence representatives to recommend one investment over another. Ask about other funds and investments that may be suitable for you at a lower cost.

1. Sales Charges

The Series A shares are available on a “no-load” basis which means that you do not pay a sales charge to the fund when you buy Series A shares.

2. Fund Expenses

You don't pay these expenses directly. They affect you because they reduce the fund's returns.

	Annual Rate (as a % of the fund's value)
Management expense ratio (MER) This is the total of the fund's management fee (which includes the trailing commission) and operating expenses	7.0%
Trading expense ratio (TER) These are the fund's trading costs.	2.3%
Fund expenses	9.3%

The fund's expenses were 9.3% of its value. This equals \$93 for every \$1,000 invested.

The fund will pay a performance fee to AlphaNorth Asset Management quarterly only if the fund outperforms the S&P/TSX Composite Index and exceeds its high water mark, over the preceding fiscal quarter or quarters since a performance fee for the Shares was last payable or since inception of the fund (i.e. start date of the fund). When these conditions are met, the performance fee payable will be equal to the excess return per share outstanding at the end of the quarter, multiplied by



20%. The high water mark is currently \$10.00, but resets each time a performance fee is paid. Effective June 1, 2017, the performance fee for this series of the fund will be based on a high water mark equal to the net asset value of the series as at that date.

More about the trailing commission – The trailing commission is an ongoing commission. It is paid for as long as you own the fund. It is for the services and advice that your representative and their firm provide to you. It is paid from the fund’s management fee and is based on the value of your investment. The rate is 1% of the value of your investment each year. This equals \$10 each year for \$1,000 invested.

3. OTHER FEES

You may have to pay other fees when you buy, hold, sell or switch shares of the fund.

Short-term trading fee

What you pay

2% of the value of shares you sell or switch within 90 days of buying them.
This fee goes to the fund.

WHAT IF I CHANGE MY MIND?

Under securities law in some provinces and territories, you have the right to:

- withdraw from an agreement to buy mutual funds within two business days after you receive a simplified prospectus of Fund Facts document, or
- cancel your purchase within 48 hours after you receive confirmation of the purchase.

In some provinces and territories, you also have the right to cancel a purchase, or in some jurisdictions, claim damages, if the simplified prospectus, annual information form, Fund Facts document or financial statements contain a misrepresentation. You must act within the time limit set by the securities law in your province or territory.
